



### 10 Million Families See a Trump Tax Hike

As Americans have filled out their taxes this year, many have been in for a shock—the sizable refund they are used to receiving has been drastically reduced, or turned into a bill for thousands of dollars owed to the IRS. For many of them, the unpleasant surprise at tax time results from withholding – in other words, they had less tax withheld from their paychecks last year as a result of changes in the withholding schedules, but the amounts were too small for them even to notice - - and now they find themselves owing the government at tax time because they’ve lost deductions they used to be able to claim.

But for about 10 million American families, including thousands or hundreds of thousands from every state in the country, the Trump tax hike was extremely real, and not just the result of changes in withholding. Due to a combination of changes including eliminating personal and dependent exemptions and capping the State and Local Tax deductions, and eliminating the deduction for employee business expenses, among other changes, these families have seen their taxes actually go up since President Trump’s tax law went into effect. Meanwhile, as a result of the same legislation, President Trump’s [political donors](#) reaped windfalls as high as hundreds of millions of dollars, and big corporations such as the [pharmaceutical industry](#) reaped billions.
