# Appendix 1, the archaeological significance of place-names in walh

This article is from the *Journal of the English Place-Name Society*, an annual peer-reviewed journal issued free to members of the Society. The *Journal* welcomes contributions of articles and notes on subjects of relevance to English place-names.

The English Place-Name Society (EPNS) was established in 1923 to conduct a county-by-county survey of the place-names of England. To date, the Survey has produced more than 90 volumes. Almost all English counties have been surveyed, at least in part, and work to complete the Survey is ongoing. The Survey is used by researchers, academics, and those interested in the origins, meaning, and significance of English place-names.

The research work and the publication of the Survey are financed by the annual subscriptions of members of the Society, with the help of grants from the Arts and Humanities Research Council and the British Academy. Since the progress and success of the Survey depend largely upon the strength of the membership, the Society always welcomes new members, both personal and institutional.

#### APPENDIX I

The Archaeological Significance of Place-Names in walh

- 1. Names of major Roman sites containing the element walh:
  - Walton Castle (Sf), Coastal fort, now lost beneath the sea.
  - 2. Walton le Dale (La) (SD 5528), Fortlet at the Flatts.
- II. Names containing walh closely associated with major Roman sites:
  - 3. Walbrook, R. (Mx), this stream flows through the centre of *Londinium* before debouching in the Thames.
  - 4. Walham, Longford, near Gloucester (GI) (SO 825202), on the valley floor only two miles NW of Glevum Colonia.
  - 5. Wallweg. This feature occurs within the bounds of Woodchester (SO 8303), the site of a large late Roman villa.
  - 6. Walworth (Sr) (TQ 325782 centre), stands at the junction of two major Roman roads opposite Londinium.
- III.Names containing walh occurring in close proximity to Roman settlements, especially villas and minor towns:
  - 7. Walcot, Swindon (W) (SU 170848). The minor town of Wanborough lies one and a half miles to the E on the main road from Silchester to Cirencester. Among other Roman occupation sites nearby is the villa at Swindon itself.
  - 8. Walworth, Andover (Ha) (SU 365455), lies close to the crossing of Roman roads one mile NE of Andover at the possible site of Leucomagus. The immediate area is studded with Roman villas and other agricultural settlements.
  - 9. Little Walden (Ess) (TL 546416), lies two miles from the minor town at Great Chesterford in a

tributary valley of the Cam. This is a well settled area in the late Roman period. Saffron Walden is two miles away.

- 10. Walford (He) (SO 586207) lies four miles SW of Ariconium, but the name occurs in an area of good land in the middle Wye valley Goodrich Castle and Flanesford Priory lie one mile to the S.
- II. Walton Farm, Grantham (L) (SK 913330) is situated one mile from the minor town at Saltersford (Cavsennae?).
- 12. Walcot, Charlbury (0) (SP 344198), in Evenlode valley, two and a half miles W of the villa at Ditchley. Complex of agricultural sites around minor town at Stonesfield, three miles to SE.

N.B. there is another walh-name, Waledenehulle, in the same parish.

- 13. Wallingford (Berks) (SU 607894). In an area of dense Roman settlement on the floor of the Thames valley. Here Grim's Ditch runs down to the river from the E.
  - N.B. Benson, two miles to the NE, was one of four settlements which fell to Cuthwulf in 571.
- 14. Walwell (and Walton) (GI), near to the villas at Whittington and Withington in a region of many late Roman villas.
- 15. Wawcott (and Wallingtons), Kintbury (Berks) (SU 390678), in the Kennett valley, only half a mile from a villa.
- 16. Walfords, Finchingfield (Ess), now lost. There are two villas close to the village of Finchingfield and the surrounding area is rich in Roman occupation sites.
- 17. Walsworth, Hitchin (Hrt) (TL 205306), is one mile N of a Roman villa in an area of fairly dense Roman settlement. The Icknield Way runs one and a quarter miles to the N.
- 18. Walcot Hall, Barnack (Nth) (TF 080042), is less than one mile from the late Roman villa at Barnack in an area of dense Roman settlement in the S. of the Welland valley.
- 19. Walcot Lodge, Fotheringhay (Nth) (TL 051938), is in the midst of dense Roman settlement on

- the terraces of the R. Nene. The villas at Apethorpe and Cotterstock are within two miles. The minor town at Ashton is three and a half miles to the S.
- 20. Walcot, Alkborough (L) (SE 879210), lies two miles NW of the villa at Winterton in an area rich in Roman settlements and iron-working sites.
- 21. Walton on the Wolds (Lei) (SK 593198) is within two miles of the large settlement at Barrow on Soar in a region of several Roman farmsteads. A Roman road crossing Fosse Way runs one and a half miles to S.
- 22. Walton, Downton (W), a lost name. There is a Roman villa in the parish, known to have been occupied at least until late in the fourth century.
- 23. Wallington, Beddington (Sr) (TQ 291641 centre). There are several Roman sites in the parish.
- 24. Wallington, Fareham (Ha) (SZ 586066 centre). There is dense Roman rural settlement in the parish, including one small village and several farmsteads and potteries.
- 25. Wellsworth, Idsworth (Ha) (TQ 734114). There is a probable Roman villa in Idsworth.
- Wealagærstune, to be identified with Woodgarston, Wootton St. Lawrence (Ha) (SU 584550). "Substantial Roman buildings", perhaps the site of a Roman villa, are recorded on the Map of Roman Britain at Wootton.
- 27. on weale weg. This feature occurs in the bounds of Burbage (W), which is just over a mile from the Roman villa at Great Bedwyn, but it is unfortunately a doubtful example of walh.
- IV. Other walh names less closely associated with Roman and early Saxon settlements but potentially significant in connection with surviving British communities:
  - 28. King's and St. Paul's Walden (Hrt), situated in the upper valley of the Mimram, close to Roman villa sites on the Chilterns; note also their proximity to Walsworth in Hitchin.
  - 29. Walcott, Happisburgh (Nf) (TG 360328), a site one and a half miles S of the Roman settlement and potteries at Ridlington.

- 30. Walton, Bosham (Sx) (SU 815045) lies two and a half miles from the Roman city of Chichester. Several Roman sites are known in and around Bosham.
- 31. Walton upon Trent (Db) (SK 815045 centre). The relationship here may be with the large post-Roman settlement at Catholme, rather than with Roman sites. The Catholme settlement (still undergoing excavation) lies one and a half miles to the S and dates probably to the sixth century and later. The Trent valley was densely settled in this stretch and Walton is thus in any case a plausible position for a late Roman settlement extending to a later date.
- 32. Walcot, Wrockwardine (Sa) (SJ 594119) is situated three miles from the Roman city of Wroxeter.
- 33. Walcot, Haselor (Wa) (SP 126582) is situated two and a half miles from the Roman town at Alcester.
- 34. Walton Farm, Folkestone (Kt) (TR 228376). There is a Roman villa at Folkestone, though it was not certainly occupied to the end of the Roman period.
- 35. Wallsworth, Sandhurst (GI) (SO 842235). There are Roman rural sites in the parish.
- 36. Walworth, West Wickham (C), a lost name. There is a small Roman rural settlement one mile S of West Wickham.

#### APPENDIX 2

The Continental Evidence: OHG wal(a)h, OSax walh

OHG wal(a)h m. has been glossed as 'Romane', OSax walh m. as 'Welscher, Kelte'. The gen. pl. wal(h)o, -a forms the first element of several Continental place-names, for example, Waldorf (Kreis Bonn, Rhineland), UUaleheim 634 (11th, 12th), 902, 973 (lost, in the Trier region), Walem (East Flanders), and Walhain-Saint-Paul (Brabant).
