

Background

The event, organized on the occasion of the eighth session of the Open Working Group on Sustainable Development Goals, will be hosted by Italy and Palau, together with the Sustainable Oceans Alliance and the Global Partnerships Forum, in cooperation with the UN Department of Public Information.

One of the most important decisions made in 2012 at the Rio + 20 conference was that the General Assembly will take action at its 68th session on a proposal for the Sustainable Development Goals; the SDGs will shape the development Agenda of the next decades and will build upon the results attained in the pursuit of the Millennium Development Goals.

The MDG, in fact, have led to the improvement of the lives of millions of people and have spurred innovative cooperation among nations and new partnerships between States and the private sector. Thanks to the MDGs poverty, child mortality, lack of basic services for all, tuberculosis, malaria, HIV/AIDS and other scourges were tracked. However, other scourges that since have become threats have not. While malaria and tuberculosis declined, millions of tons of ice vanished, thousands of ocean species disappeared, food chains got disrupted and ecosystems decayed. True, the preservation of the health of the Oceans and Seas was not an explicit MDG goal. But now the international community has become aware of the fact that the health of the oceans and seas is a condition for survival on the Earth. Thus, the health of Oceans and Seas must be a pivotal component of the SDGs. Islands and coastal nations are banding together to create Healthy Oceans by 2030.

The event will serve as a catalyst for action, a lead-up to the July 2014 Pacific Island Summit in Palau, the September 2014 United Nations Conference on Small Island Developing States in Samoa and the Summit on Climate Change that the Secretary General has called for September of this year. The discussion will bring together world leaders and policy-makers, representatives from civil society and the business community, as well as international organizations. The event will also highlight innovative technologies that will help us to better preserve our common natural heritage.
